Mr. Volpe joined Dresser in 1981 and over the past 34 years held positions of increasing responsibility in Engineering, Marketing, and Operations in the USA, Venezuela, Japan, France and the UK. In 1999 he was named Chief Operating Officer, responsible for worldwide manufacturing, technology and supply chain management, serving in that position until September 2000 at which time he became President and Chief Executive Officer of Dresser-Rand Company.

Mr. Volpe is proficient in five languages and earned a BS in Mechanical Engineering and a BA in German Literature from Lehigh University. He also serves on the Board of Directors of the **FMC Company (NYSE:FMC)**, as a member of the Audit Committee and Chairman of the Nominating and Governance Committee.
